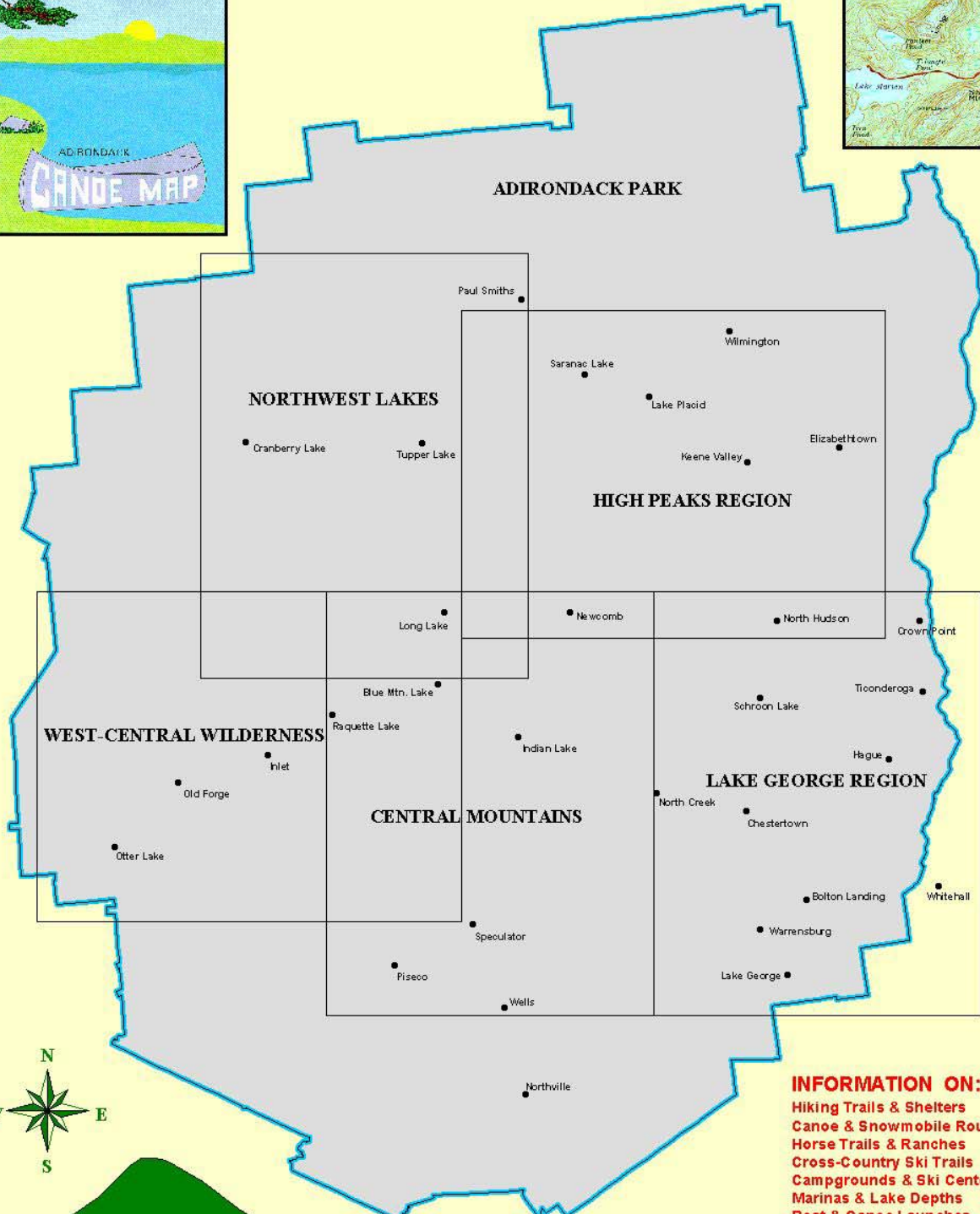
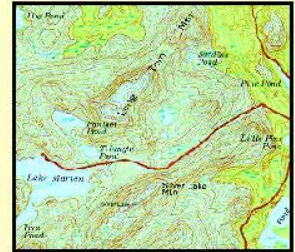
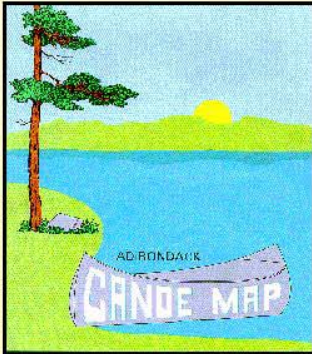

RESALE CERTIFICATE
CANNOT BE USED TO PURCHASE AUTOMOTIVE FUEL

The vendor must collect the tax on a sale of taxable property or services unless the purchaser gives him a properly completed resale certificate or other exemption document.
